

VOLUME LICENSE AGREEMENT FOR DIGITAL BOOKS FOR BABIES CONTENT

This License Agreement (the "Agreement") governs the terms by which Users download digital art files and other media content (the "Content") from the American Library Association ("ALA"). Please read this Agreement carefully before downloading any Content. By downloading any Content, you agree to be bound by the terms of this Agreement. If you do not agree with the terms of the Agreement, do not download any Content.

You represent and warrant that you are 18 years of age or older, are lawfully able to enter into and perform a legally binding contract and agree to be bound by the terms and conditions in this Agreement, in the event you choose to download Content. Please print a copy of this Agreement and retain it for your records.

With the purchase of the Content, ALA grants the Registered User ("User") a license to reprint the Content, but only within the context of the Content and subject to the quantity limits and conditions below.

BASE LICENSE

The Base License Option allows the User to reprint the Content up to 1,000 copies each calendar year. ALA grants User a personal, non-transferable, non-exclusive, right (subject to quantity restrictions and ALA's right to terminate below) to use the downloaded Content for permitted purposes. If User will exceed Base License quantity limit of 1,000 units, User will need to increase license level as indicated below.

License covers a single library, Friends of the Library group (nonprofit organization established to fundraise for a library), or other organization and may not be shared with another library, group, or organization whether part of a consortium, county, regional, or state system.

The User may not use or display the Content in an electronic format that enables it to be downloaded or shared in any peer-to-peer or similar file sharing arrangement by persons not employed by or acting as agents under the direction and control of the User.

EXPANDED LICENSE LEVELS

The Expanded License option allows the User to reprint the Content up to the quantity listed for the License Level purchased each calendar year. ALA grants User a personal, non-transferable, non-exclusive, right (subject to quantity restrictions and ALA's right to terminate below) to use the downloaded Content for permitted purposes. If User will exceed the Expanded License quantity limit purchased, User will need to increase license level as indicated below.

LICENSE LEVEL 2:	1,001 to 2,500 reprints per calendar year
LICENSE LEVEL 3:	2,501 to 5,000 reprints per calendar year
LICENSE LEVEL 4:	5,001 to 7,500 reprints per calendar year

License covers a single library, Friends of the Library group (nonprofit organization established to fundraise for a library), or other organization and may not be shared with another library, group, or organization whether part of a consortium, county, regional, or state system.

The User may not use or display the Content in an electronic format that enables it to be downloaded or shared in any peer-to-peer or similar file sharing arrangement by persons not employed by or acting as agents under the direction and control of the User.

PROHIBITED USES

User may not do anything with the Content that is not expressly permitted in the licensing option(s) purchased. ALL licensing options are subject to the following terms and conditions:

- a) No portion of the Books for Babies Rack Card Content may be changed, edited, or removed; user may add any information to the back of the card.
- b) No portion of the Books for Babies Brochure may be changed with the exception of the editable blank space on the back panel. The logo, "is an initiative of" and United for Libraries logo at the bottom of the back panel may not be edited, changed, or removed.
- c) The User may not use the Books for Babies logo or images for any purpose without the explicit permission of United for Libraries.

- d) The Content is for use by non-profit entities for the sole purpose of promoting libraries, literacy, and reading (the "Purpose").
- e) The Content may not be used by any individual or entity that is for-profit and may not be incorporated in products offered for sale or used for commercial, advertising, or marketing purposes other than in furtherance of the Purpose. For sake of clarity, no for profit entity may sponsor, promote, be affiliated with or otherwise use the Content for any purpose. Use of any for profit entity, name, logo or trademark on or in connection with the Content is expressly prohibited.
- f) The Content may not be incorporated in a product for the purpose of redistributing the Content, and the Content may not be sold, relicensed, rented, or made available for download by third parties.
- g) Pornographic or defamatory use of the Content is prohibited.
- h) All copyright notices or other statements of attribution contained in the Content may not be removed for any reason.

ALA has the right to review your use of the Content and to request that the use cease or be changed. You agree to comply with any such request made by ALA.
